#### 9:00 - 9:15 Welcome and Introductions

#### 9:15 – 9:45 Partner Updates

- <u>CSU Extension</u>
  - Oct 26, all day: Cattlewomen College
    - Opportunity for women to learn more about ranching in our area
  - Oct 2: Cottage Foods class
  - Oct 19: Shred Day TBK parking lot; supports 4H
  - Oct 12: 4H Open House Day
  - Nov 3: ServSafe class for restaurant workers
- <u>NRCS</u>
  - San Juan Conservation District
    - WEP: finishing up inventory on ditches in Pagosa Springs
  - Working to finish RCPP forestry work in southern part of County
  - Closing fiscal year
- <u>WAP</u>
  - Closing everything for 2021; have grants lined up and getting ready for spring
  - Crost-share programs for fire mitigation in PLPOA and in all communities accessed off HWY 184 from Pagosa Springs to NM border
  - PLPOA will assess green belts in 2022
    - 850 aces of green belt create an extreme fire hazard
    - Owned by Wyndom, but PLPOA trying to get control to do mitigation work
    - Work will tie into work happening ion Brockover Mesa
  - o CAFA Program finished
    - 3 more properties in this year
    - All grant funds utilized
      - State gave 2 extensions
    - A story to spread far and wide

- <u>Monitoring</u>
  - TRAM Committee: Technology Research Assessment and Monitoring for 2-3-2 Partnership
    - Having initial monitoring planning development meeting for Rio Chama CFLRP next Monday
    - Forest Stewards guild (FSG) and MSI are working on monitoring plan
    - Will be a long road with lots to discuss
    - Relevance to SJHFHP work and vice versa
  - o ASCC
    - Interest in developing snow and moisture monitoring at ASCC site using snowtography (wildlife cameras, snow stakes, soil moisture gauges)
    - Currently setting up snowtography on DWRF landscape as part of a beta test to guide methodology
    - Stakeholder and partner involvement required for this effort including set up and site maintenance, analysis also critical
      - Straightforward set: one full planning day in field with small group of people that are informed decision makers (like PIs) and a second day to climb ladders, setup wildlife cameras, and pound in stakes in ground
      - Maintenance done 1x/week when snow is on the ground
        Check SD cards, batteries, and measure snow depth
      - Would help look at how treatments influence water and snow dynamics
        - Potential partnerships with FLC, 4 Corners Water, RMRS
    - Mike Battaglia and RMRS have some budget for ASCC site and may be willing to spend on equipment and supplies
    - Want to install post-treatment, probably Fall 2022
      - Time to plan, seek partners and grant funds
- <u>SJNF</u>
  - o Turkey Springs vegetation management EA complete
    - press release to come out today
    - Robust fuels treatments
    - Implementation to begin Spring 2022

### 9:45 – 10:00 Pagosa Creek Tour Friday, October 15<sup>th</sup> 8am-noon

- <u>Pagosa Creek IRTC Contract</u>
  - CRS Timber finished timber treatment last month
  - Treatments in Mixed-Conifer aimed to retain fire adapted species, use and promote Aspen
  - Experimental treatment and unique timber sale in Mixed-Conifer, unusual in Colorado and lots of learning opportunities

- While many collaborative conversations around wildfire risk reduction this Tx is far from the community, so the primary objective was not risk reduction
  - why would we treat so far away from communities and what are we trying to achieve?
  - Reasons beyond community protection to manage resources
- High diversity on pre-treatment landscape and treatment aimed to promote variability and diversity
  - E.g., stands that are ponderosa pine or white fir dominated
  - Imagine more economic goals of forest management and management of complex forest types
  - Mimic ecological processes and disturbance while also aiming to support forest products economy
- $\circ$  Recreation
  - Black Mountain Road through treatment areas accesses Pagosa Peak
  - During pre-treatment monitoring, was surprising how many people walk through this area
  - Josh to report back if PRD starts hearing from public about treatment impacts on rec use
- <u>Tour</u>
  - SJHFHP toured Pagosa Creek in 2019 so Oct 15<sup>th</sup> tour will be a follow-up with the intention of touring again in a few years to look at Tx impacts
  - Topics of interest
  - Tour in morning, logistical information will be sent in the coming weeks
- <u>Huerto Creek</u>
  - Has work started at Huerto Creek (close to William's Reservoir)?
    - Yes, work has started
    - Not much input from rec users, but hearing a lot about trucks on Piedra Rd

#### 10:00 - 10:15 SJHFHP Finances

- <u>Funding</u>
  - Sources have shifted since July
  - Cohesive dollars spent down, working on different and new agreements with Forest Service in addition to other sources and also using cash account
    - Cash reserve in healthy spot
  - Dana to meet with MSI finance director Jeff Connors next Tuesday
    - New sources of funding from agreements and small amount of money from ToPS and other sources
    - Setting up trackers that will be used to inform SJH budget
    - Finance committee to meet soon to discuss Q3 numbers
  - Changing some line items mid-year in budget to accommodate changes in funding
- Finance team meeting
  - Call for an additional finance team member

- Four meetings per year and time at end of year planning for following year
- Budget season and fiscal asks: PAWSD, SJWCD, BPR, Alpine Cascade Ranch
  - Asks of agencies and groups that have supported SJH in the past
    - SJWCD
      - Presentation October 18<sup>th</sup> to highlight work we're doing and value of partnership
      - Donated \$1,500 last year and would like to increase to \$2,500 this year
      - Budget not yet approved but \$2,500 is in budget and will likely be approved in December
    - PAWSD
      - Presentation Tuesday October 17<sup>th</sup> to ask for ongoing support
    - Dana to reach out to Tim Haarman with Banded Peak and JR Ford
    - Other ideas of groups or entities to approach for funding?
  - Fundraising with Mike Remke
    - Landscape photography calendar co-sponsored by SJHFHP to raise funds
    - Use of SJH email list for marketing
    - SJH's support and maintain creative freedom of creating/designing calendar with forest ecology theme; will include SJH logo and donate 50% of the profits to the collaborative
    - All in support!

#### 10:15 – 10:45 SJHFHP News

- <u>Pagosa Area Trails Council (PATC)</u>
  - Letter of support requested
    - Need letter by October 4
    - SJHFHP partners support writing a letter for the PATC
  - History:
    - Goal to clear trees from trails
    - Raised ~\$70-80,000 from various sources to accomplish this goal and working with trails manager of Pagosa District
    - CPW grant, put down \$20,000 and got another \$13,000
    - Applied for and received \$106,000 grant originally planned for 2020 and 2021
    - Rocky Mountain Region gave another \$60,000 the PATC can carry into 2022
    - Applying for \$150,000 to cover 2022 to 2024
  - Accomplishments:
    - 2018: cleared ~4,600 trees representing ~50% trails with backlog on ~485 trails
    - 2019: cleared ~6,000 trees; ~80% of trails
    - 2020: 6,500 trees cleared; 100% of trails cleared and no more backlog

- 2021: ~5,100 trees cleared; 100% of trails cleared
- Must clear ~5000 trees/year to keep trails safe
- o Cost:
  - ~50\$ per tree to clear as trails are in wilderness areas and crosscut saws are required
  - Grant money to SWCC
  - Over 3,000 volunteer hours (Backcountry Horseman, retired foresters, Great Old Broads)
- o Updates:
  - Article in paper yesterday with updates and success story
  - Trail clearing and maintenance is long-term problem
- Dana will write letter of support and communicate with SJH email list about the LOS, contact Dana with any feedback and/or concerns
- <u>Regional</u>
  - SW CO CFLRP
    - Small group working to hire 3<sup>rd</sup> party facilitator
      - At Nov 2020 CFLRO intro meeting Courtney Schultz presented her research about CFLR's and a primary indicator of success was a 3<sup>rd</sup> party facilitator involved in governance setup and communications structures
      - Identification of needs and funding
        - LPEA gave \$5,000
        - CFRI gave \$5,000
        - SJNF gave \$5,000
        - These funds are separate from CFLR funds that have yet to be appropriated
      - RFQ drafted and distributed in June
      - Interview of qualified applicants ended last week and working group is in the process of offering the position the top candidate, no contract signed yet
    - Important for SJHFHP to get involved in communication channels and governance structure drafting so we can be sure those processes work for the Partnership
      - Work to start Nov/Dec and last 3-4 months; time limited commitment to being involved in setting up governance and communication structures
    - Clarification on hiring processes and funding procedures
      - A committee formed with representatives from across SJNF did the fundraising and is working to hire the facilitator
      - Money will be managed by Onward
      - MSI just one stakeholder in the conversation
      - Hiring Committee: Dana Guinn (MSI), Danny Margoles (DWRF), Anthony Culpepper (MSI), Aaron Kimple (MSI), Lo Williams (SJNF), Bill Baker, Melissa Simmons (CSFS), and Jason Lawhon (USFS)
    - Why hire before CFLRP funding allocation?

- Once funding for CFLRP is appropriated we have 6 months to develop a prioritization scheme and 3<sup>rd</sup> party monitoring program for the next 10 years
- If we're set up with clear communications channels and know how we will deal with recommendations and decisions, we'll be much more efficient
- What if CFLRP funding doesn't come through?
  - Value in developing communication channels and to that outside of CFLRP
- o <u>2-3-2 Focal Area development</u>
  - Last month SJH spent time developing draft focal areas
    - Focal Areas: Larger areas within our geography (100-200k acres) and identifying opportunities to complete work on the ground in specific jurisdictions and in specific regions
      - Rio Chama CFLRP driving this process (SE portion of SJH geography)
    - Focal Areas: SJH created *Focus Areas* in 2014; *Focus Areas* of the SJH are smaller than *Focal Areas* that the 232 is utilizing
      - SJH can make focal areas any size we like
  - Focal areas will help SJH describe what's important on landscape, why, and the opportunities for working there
    - Important to tell these stories as both CFLRP's get rolling
    - Describe values, potential for work, concepts that we care about (e.g., improving industry capacity to reinvest in work on our landscape)
    - Opportunities to leverage money and work with various partners
      - Identification of focal areas helps align and secure funding and/or capacity in the future (e,g., NRCS hiring, Joint chiefs funding)
  - Draft focal areas at 232 Full Partnership Meeting Sept 15

- <u>Legislative</u>
  - Senator Hickenlooper's Office
    - Budget Reconciliation Bill
      - Forestry-specific strategic investments

- Pending/potential forestry funding allocated for private and public forested lands
- Highlights
  - ~\$20 billion to address wildfire crisis via fire mitigation, controlled burns, thinning, etc.
  - $\circ$  ~\$1 billion to USFS for landscape restoration
    - Private landowner fund access with a focus on disadvantaged landowners and building public-private relationships
  - \$4.5 billion to new Civilian Climate Corps
  - House Ag Committee has an opportunity to allocate an additional \$20 billion for wildfire adaptation
    - Will look different once it gets through Senate; will know what it entails in mid-December
  - Senator Bennet is on both the Energy and Natural Resources Committee and Ag Committee, where most funding for forestry will come from
- Other Information
  - Funding for sedimentation ponds, emergency/evacuation routes also of interest
  - Advancing the use of small-diameter wood
    - Table to farm wood chips in compost
    - o CLT, TimberAge
    - JR Ford in Archuleta County and his vision to generate and distribute energy locally
    - 4FRI innovating ways to utilize small-diameter timber by exporting internationally
      - Not an option in CO due to geography and trucking
    - Place-based collaboratives are able to come up with place-based solutions
- Thank You to Senator Bennet and Senator Hickenlooper
- <u>SJNF</u>
  - V Rock land acquisition proposal
    - Approached by potential purchasers of an in-holding regarding road maintenance, which spurred discussion about wildlife impacts
      - Elk migration corridors (through Valle Seco onto SUIT lands) and winter range
    - Landowner and Rocky Mountain Elk Foundation interested in sale to USFS
    - Proposal supported by RMEF submitted to Land and Water Conservation Fund submitted today
    - 2 proposals from SJNF:
      - V Rock on PRD
      - Dunton Meadows on Dolores Ranger District

- If accepted, funds to purchase likely allocated in Spring 2023
- Acres and cost
  - ~160 acres; cost based on listed price ~\$1,000,000 (~\$6,000/acre)
    - RMEF worked with landowner to secure option on property whole SJNF works to secure funding for purchase
- Chimney Rock Fee Schedule
  - 1-pager forthcoming
  - Background:
    - Have requested to start collecting fees at Chimney Rock and Forest Service process includes a public comment phase
    - Public comment period ends at end of September
    - FS will analyze public comments and based on comments and public support will issue a legal notice in spring 2022 to move forward with the fee proposal with the goal of implementation in May 2022
  - FS wants to charge a standardized fee per vehicle that aligns with national monuments and parks across county and better honors discount passes
  - The FS wants to pursue this because Chimney Rock has seen visitor use double in last 10 years and staff expects visitor use to increase more
    - Constructed new Visitor Center that will likely draw more visitors
    - Don't have facilities/maintenance capacity to cope with increased visitation
    - Fee will help provide funding for operations
  - In the past Chimney Rock Interpretive Association (CRIA) has been in charge of day-to-day operations and the FS provided oversight
    - Will change so that FS is in charge day-to-day operations
    - CRIA will continue interpretation work, events, and gift shop/visitor services
    - Some volunteers doing tours have expressed unhappiness with the changes, has the FS communicated with them?
      - In steady communication with CRIA, interested in learning more about specific concerns

  - Public events have been difficult since 2020
  - Online presence needs improvement
    - May be something SJH offers extra support with; MSI discussing additional support here
  - Look to ways to cross-pollinate with partner organizations
  - Want events to advertise, EG: biking/hiking Tour at Turkey Springs
    - Would need ed/outreach help/support with this
- Annual mapping and planning
  - Has happened in April last several years
  - Think about changing to earlier in year because of landscape-scale initiatives, would like to have information to share with partners earlier in the year
